Dear Pastor Monti,

Re.: Assistance to Refugees

I have the pleasure to inform you that our Finance Department has been authorized to transfer to your account US-\$ 60,000.

It is thanks to the generosity of the Swedish SIDA that we are able to make this contribution towards your work with refugees in Buenos Aires Bahia Blanca and Neuquén. The share for Mendoza (US-\$ 40,000) was transferred direct to Rev. A. Verhoeven as per enclosed copy.

As mentioned therein, the financial outlook for 1976 is not good and the realities which will have to be faced on the next months are likely to be worse. Whatever funds we get should be used mainly in a way which enables the refugees to become self-supporting and I trust your programme and estimates for 1976 will place more emphasis on permanent solutions than on emergency assistance.


