Dear Mr Winshot:

Regrettably, the talk we held on September 8 inst., was not long enough to clarify the situation CAREF is going through and I would like to widen it here.

During 1979 and up to April 1980, CAREF's Board members were:

At the beginning of June I was appointed Pro-treasurer for as from the end of April no member of the Board was in charge of financial matters. All problems concerning funds were handled by the Treasurer, who informed about them to the Executive Secretary, Norberto Ianni. Ianni is a psychologist and has no financial knowledge.

In our March 15, 1979 telex we submitted our 1980 budget forecast amounting to uss 250.000.- On October 22, 1979 we sent our final 1980 budget for uss 300.000.- On November 21, Mrs Saintsew replied that our budget had been accepted so we thought we would receive uss 300.000.-

Detail of assistance received from WCC follows:

In January there were still \$ 42,350 dollars left. Most of this money was intended for permanent solutions which had not been paid up in December.

From this money we have blocked the first two amounts 75, and 75,000 reducing in that way our expenses "to manage with what we have got."

In June, and for one month, UNHCR granted us a loan in pesos for the equivalent of uss 8,900. It has not been demanded yet.

Our needs were reduced to the minimum so that we do not carry out certain personal assistance services in order to continue with the programme.

The regional offices (branches) represent for CAREF fixed costs (cases, ck) of u\$s 7,100. From this amount u\$s 3,200 are covered by WCC and u\$s 3,900 by the UNHCR. Our debts at September 11, were u\$s 33,200, so we can only cover our needs till the end of September.

## Summary

Due to the present situation and considering that only by the end of the year we hope to recover part of the invested money, we estimate our needs will be:

If we are unable to solve the financial aspect, we would also need uss 15,000 for each month from January to Match (it must be taken into account that the economy is somehow paralized during January and February due to the summer holidays.

You were also visited by our social area coordinator, Mrs María Amelia de Sosa who spoke about 1) enlargement of migrants programme, 2) enlargement of Indo-Chinese refugees programme. Part (1) discarded due to actual situation, and we will keep you informed about (2) in case it is carried out. Said programme, (2), might represent an additional income of u\$s 60,000 per month from UNHCR and that would enable us to cover some expenses. So we estimate our needs from WCC could be reduced to about \$ 10 to 12,000 per month.

I hope this report, containing only administrative data -those of the programme itself are detailed in a separate mail-, will help you understand even better the extremely difficult situation we are going through in CAREF.
